
Special Notes

We collected 7.3 pounds of pills this month.

We received a grant reimbursement in the amount of \$374.98 from the Department of Justice's Bulletproof Vest Program for a bulletproof vest.

Total cost of bulletproof vest - \$690.00 BVP Reimbursement - 374.98 Previous NCLM reimbursement -250.00 Net cost to Village \$55.02

Officers began handing out coupons for free ice cream from Cold Stone Creamery to children who are 10 and under if they are caught wearing a helmet while riding their bicycles. Senior Officer Holt went to several businesses to find one that would assist us with this program.



On May 5th our department held an Open House. Police vehicles and the police boat were displayed. We also had a seatbelt convincer that simulates a low impact collision to stress the importance of wearing a seat belt. NC Safe Kids had a booth and offered to do free child seat checks. NC Wildlife Officers also set up a booth about water safety and brought their boat to display. There were activities for the children and many people took a tour of the renovated police building. We also had some light refreshments for those attending. We want to thank everyone who assisted with the open house and everyone that attended the event.

Events of interest for the month of May 2018

1. There were twenty-one (21) incidents that were investigated this month.

- May 3rd Violation of Village ordinance (dog at large). A loose dog was walking through the police department parking lot. The officer recognized the dog as belonging to a Fairway Lane resident. The dog was placed in the kennel and the officer attempted to contact the dog owner. A message was left for the dog owner. The dog owner did not call back so animal control was contacted and they came and picked up the dog. The dog owner was issued a civil penalty for this violation as this was the 8th violation in the last year.
- May 3rd Simple assault. As a result of a traffic stop the officer determined that the driver of the vehicle had an active warrant for arrest out of New Hanover County for simple assault. The driver was placed under arrest.
- May 4th Driving while license revoked. As a result of a traffic stop the officer remembered stopping this same individual two weeks earlier for driving while his license was suspended. The officer confirmed that the driver's license was still suspended. The driver had several traffic related citations in his history and had a history of failing to appear on many of his previous charges. So, the officer placed the driver under arrest for driving while license revoked.
- May 7th Possession of marijuana, possession of marijuana paraphernalia and resisting, delaying, and obstructing. As a result of a traffic stop the officer detected some tobacco guts from cigarillos which are often used to smoke marijuana. The officer asked for permission to search the vehicle and the driver said no. Then an officer saw pill bottles in the back seat of the vehicle. When asked if the pill bottles were hers she reached around to the back seat and then the officer witnessed a burnt marijuana cigarette and a lighter that had been under her leg. The driver was advised to step out of the vehicle and the driver refused. She rolled up the window and locked the doors. The driver was advised if she did not cooperate she would be forcefully removed and taken to jail. The driver then ate the marijuana cigarette before getting out of the vehicle. The officer searched the vehicle and found a marijuana pipe, a grinder, and a glass jar with marijuana in it. All of the items were photographed and then seized for placement into evidence. The driver was arrested by citation for possession of marijuana, possession of marijuana paraphernalia and resisting, delaying and obstructing.
- May 8th Failure to pay monies. As a result of a traffic stop for speeding the officer determined that a passenger in the vehicle had an outstanding order for

- arrest out of Lee County for failure to pay monies. The officer issued the driver a warning ticket for the violation and placed the passenger under arrest.
- May 10th Possession of drug paraphernalia. As a result of a traffic stop the officer requested to search the vehicle which the driver allowed. The officer found multiple syringes in the car and a can that had been used to smoke illegal drugs. The officer photographed these items and seized the items for placement into evidence. One of the passengers in the vehicle claimed the items belonged to her. So, the passenger was given a citation for the possession of drug paraphernalia. The driver received a citation for driving while license revoked.
- May 10th Violation of Village ordinance (dog at large). A resident of Sabbatia Drive reported finding a loose dog. The dog belonged to another Sabbatia Drive resident. The dog owner came to pick up his dog and the officer issued him a warning ticket since this was the first violation.
- May 14th Driving while impaired. An officer observed a vehicle weaving on the roadway and pulled the vehicle over. When the officer approached the vehicle, he could smell the odor of alcohol. The driver appeared impaired. The officer had the driver get out of the vehicle and perform several roadside field sobriety tests. The officer had to stop the tests as the driver was having a hard time standing without falling. The officer placed the driver under arrest for driving while impaired.
- May 15th Driving while license revoked. As a result of a traffic stop the officer determined that the driver had two orders for arrest out of Lee County for failure to appear on a driving while license revoked charge and an expired registration charge. The officer issued the driver citations for driving while license revoked, expired registration, and an inspection violation. The driver was then placed under arrest.
- May 15th Possession of marijuana and possession of drug paraphernalia. As a result of a traffic stop for speeding the officer detected the odor of marijuana when he approached the vehicle. The officer searched the vehicle and found a glass pipe, grinder, and some marijuana. The officer also found a glass pipe in a passenger's purse that contained marijuana residue in it. The officer photographed the items and then seized the items for placement into evidence. The driver was given citations for speeding, possession of marijuana, and possession of marijuana paraphernalia. The passenger was given a citation for possession of marijuana paraphernalia.
- May 17th Vehicle fire. An officer was dispatched to a residence on Lakeview Drive for a reported car fire. The owner of the car stated that he had put a battery charger on the parked vehicle and went inside the house. A neighbor came over banging on his door to let him know his car was on fire. The owner stated that he tried to put the fire out with a hose and unplugged the battery charger. The fire department was also on scene and ensured the fire was out.

- May 18th Careless and reckless driving. An officer received a call from someone in the Food Lion parking lot about someone driving a vehicle recklessly in the parking lot. The officer obtained a statement from the witness and spoke to the driver of the vehicle. The officer could smell the odor of burnt rubber coming from the vehicle. The driver was a 15-year-old that did not have a license yet. He was waiting for his grandmother to come out of the grocery store. The officer also obtained video from Food Lion which shows the manner that the driver was driving in the parking lot. The officer is obtaining a juvenile petition for careless and reckless driving.
- May 18th Voluntary commitment. An officer was dispatched to a Hammerstone Circle residence in reference to a suicidal person with a gun. When the officer arrived, he spoke with a friend of the resident who said the resident was not home but had been very upset and threatened that she was going to shoot herself. The resident returned home and was obviously very upset. The officer had the resident get out of the vehicle and go into the residence. The officer had the friend park the vehicle. A gun was in the house so the officer took the gun for safekeeping. The officer was able to get the resident to agree to be checked out by EMS and the resident voluntarily agreed to go to the hospital to be evaluated.
- May 20th Violation of Village ordinance (barking dog). A resident of Ray's Bridge Road reported his neighbor's dogs had been barking for a few hours. The officer could hear the dogs barking as well. The officer went to the dog owner's residence and issued a civil penalty to the dog owner as this is the 8th violation by this dog owner in the past year.
- May 21st Violation of Village ordinance (dog at large). A resident of Pine Ridge Drive reported that a loose dog was walking around and the dog did not appear to be in good shape. The officer went to Pine Ridge Drive and found the dog. The officer picked up the dog and placed the dog in the pen at the police station. A short while later another resident of Pine Ridge Drive called the police department looking for her dog. The dog owner came to the police station to pick up her dog. The officer issued the dog owner a warning for the ordinance violation since this was the first violation.
- May 22nd Driving while license revoked. As a result of a traffic stop the officer determined that a passenger in the vehicle had two outstanding orders for arrest out of Hoke County for failure to appear on a driving while license revoked charge and failure to wear seat belt charge. The officer issued a citation to the driver for driving without being licensed. The passenger was then placed under arrest.
- May 24th Damage to personal property. A resident of Sandpiper Drive reported finding a hole in his vehicle's rear bumper that looked like a bullet hole. The officer observed the hole and agreed it looked like a bullet hole. There was

- no bullet lodged inside of the bumper. The owner states he keeps the vehicle parked in the garage and there are no holes in the garage door.
- May 26th Natural death. A resident of Sunset Drive contacted 911stating that his spouse was unresponsive. When the officer arrived rescue members were performing CPR. The resident stated he went outside for a little while and when he came back inside he found his wife on the floor and she lost consciousness. He called 911 and they instructed him to start CPR. EMS was unable to revive the patient. The officer contacted the funeral home for the husband and the officer stayed at the residence with the husband until the funeral home arrived.
- May 28th Fugitive/extradition for another state. As a result of a traffic stop the officer learned that the driver of the vehicle had an active fugitive warrant out of Mississippi for embezzlement. The officer had the driver step out of the vehicle and then advised him of the warrant. The driver was placed under arrest and the officer transported him to the police department so the officer could complete some paperwork regarding the warrant that had been faxed. The officer then transported the driver to the Moore County Jail.
- May 30th Violation of Village ordinance (dog at large). An officer observed a dog running loose in a park on Lakeview Drive. The dog owner was a resident of Herons Brook Drive. The officer issued the dog owner a warning ticket for the violation as this was the first violation for this dog owner.
- May 31st Violation of Village Ordinance (dog at large). A resident brought a loose dog he found to the police department. A short time later a Lakeview Drive resident called to see if we had found his dog. He came to the police department to pick up his dog and was issued a warning ticket for the violation since this was the first violation for this dog owner.

2. There were eleven (11) arrests this month with a total of 19 charges. After an arrest, officers are unavailable for at least 2 hours while processing and booking subjects at the Moore County Jail in Carthage. Serving a criminal summons does not require detaining or taking the subject to jail.

- May 3rd As a result of a traffic stop the officer determined that the female driver of the vehicle had a warrant for her arrest out of New Hanover County for simple assault. The driver was placed under arrest and transported to the Moore County Jail.
- May 4th As a result of a traffic stop the officer determined that the driver's license was suspended. The driver admitted to knowing this and in fact had been stopped a couple weeks earlier by the same officer for driving while his license was suspended. Due to the driver's driving history and failure to appear on prior citation charges the officer placed the driver under arrest and transported him to the Moore County Jail.

- May 7th As a result of a traffic stop and search of the vehicle, the officer found a glass jar with marijuana, a pipe, and a grinder in the vehicle. The driver initially refused to get out of the vehicle and locked the doors and rolled up the window so she could swallow a burnt marijuana cigarette that she had in the vehicle. The officer had to repeatedly advise the driver that if she did not get out of the vehicle the officer would get her out. The driver was arrested by citation. The charges were possession of marijuana, possession of marijuana paraphernalia, no insurance, and resisting, delaying and obstructing an officer.
- May 8th As a result of a traffic stop for speeding the officer determined that a passenger in the vehicle had an outstanding order for arrest out of Lee County for failure to pay monies. The passenger was placed under arrest and transported to the Moore County Jail.
- May 10th As a result of a traffic stop the officer found drug paraphernalia in the vehicle. One of the passengers in the vehicle claimed the items. The passenger was arrested by citation for possession of drug paraphernalia.
- May 14th After observing a vehicle weaving in the roadway the officer stopped the vehicle. The officer could smell the odor of alcohol coming from the vehicle, so he had the driver get out of the vehicle and tried to perform several roadside field sobriety tests. The driver did not do well on these tests and due to the driver having trouble standing the officer decided to end the tests. The driver was placed under arrest and transported to the Moore County Jail. The driver had a blood alcohol content of .10.
- May 15th As a result of a traffic stop the officer determined that the driver had 2 active orders for arrest out of Lee County for failure to appear on a previous driving while license revoked charge and an expired registration charge. After the officer issued the driver citations for again driving while license revoked, expired registration, and an inspection violation the driver was placed under arrest and transported to the Moore County Jail.
- May 15th (Two arrests) As a result of a traffic stop the officer ended up searching the vehicle after smelling the odor of marijuana inside the vehicle. The officer found a glass pipe and a grinder that contained some marijuana inside the vehicle and a glass pipe in the passenger's purse. The items were seized and the driver was arrested by citation for possession of marijuana paraphernalia. The passenger was arrested by citation for possession of marijuana paraphernalia.
- May 22nd As a result of a traffic stop the officer determined that the passenger had two active orders for arrest out of Hoke County for failure to appear on a driving while license revoked charge and failure to wear a seat belt charge. The passenger was placed under arrest and transported to the Moore County Jail.

• May 28th – As a result of a traffic stop the officer ascertained that the driver had an active fugitive warrant out of Mississippi for embezzlement. The driver was placed under arrest and transported to the Moore County Jail.

3. There was one (1) traffic accident in the Village this month.

• May 20th. An accident occurred in the Food Lion parking lot. A vehicle entered the parking lot and was pulling into a parking space and struck a parked vehicle and actually ended up on top of the parked vehicle. The parked vehicle was unoccupied at the time. The driver was issued a citation. The parked vehicle had to be towed from the scene. There were no injuries reported.

4. Safety (Department)

• The Village continues to provide the department with the funds to allow us to buy equipment and provide training to make our officers as safe as possible.

5. Safety (Village)

- Officers have conducted numerous saturation patrols this month on Lakeview Drive and Pine Ridge Drive.
- Sgt. Graham worked with the Village public works crew to reposition ski buoys on Thagard Lake to make boating safer for all.

6. Other Events of Interest

- May 9th Lt. Dozier attended the monthly Investigators Meeting that was held at the Pinebluff Police Department this month. Issues of common concern are discussed among local law enforcement agencies at these meetings.
- May 23rd Chief Campbell and Senior Officer Holt attended the US Army Counterintelligence and Law Enforcement Conference at Fort Bragg. This conference was to promote information flow between organizations and provide an opportunity to inform law enforcement on Army counterintelligence and army assets in North Carolina.

GOALS AND OBJECTIVES

Goal #1: To provide a uniform standard that will enable personnel of the department to be more consistent in procedures when handling situations.

Objective #1: Daily briefings are being conducted by officers at shift changes. The Lieutenant and Sergeant have also discussed monthly schedule and operational concerns with all officers this month.

Objective #2: General Order 040 – Interaction With the Mentally Ill was revised this month to include a form about the North Carolina involuntary commitment process.

Objective #3: All officers completed policy reviews of General Order 040 – Interaction with the Mentally III, General Order 041 – High Visibility Traffic Vest Usage, and General Order 042 – Naloxone Narcan Usage.

<u>Goal #2:</u> To provide for education and further development of department personnel to enhance officer and department professionalism.

Objective #1: All officers watched a training video that depicts officers confronting a suspect with outstanding warrants inside a residence. The suspect is fatally shot and an officer is stabbed during the encounter. The video discusses how officers should trust their instincts and when things get out of hand to always stay in the fight.

Officer Hinson completed the mandated in-service training "Strategies to Improve Law Enforcement Interaction with Minority Youths" on May 7th and 2018 Equality in Policing on May 20th.

Senior Officer Holt completed the 3-day Body Language and Deception in High Risk Environments course at Wake Tech Community College on May 11th.

Lt. Dozier, Master Officer Tate, and Senior Officer Holt completed the mandated in-service training 2018 Legal Update this month.

Sgt. Graham completed the mandated in-service training 2018 Equality in Policing on May 22nd.

All police officers completed the on-line training course Working in Extreme Temperatures and the police administrator completed the on-line training course Office Safety this month as required by the Village Manager.

Goal #3: Provide for a higher degree of personal contact between community and department personnel.

Objective #1: There were no community events held this month.

Senior Officers Holt and McNeill gave a Cub Scout group a tour of the police building and also showed them some of our police vehicles on May 23rd.

Objective #2: Officers welcomed 4 new residents this month and provided the new residents with a police "Welcome Packet" describing many of the services offered by our department.

Objective #3: There were no requests for Child IDs this month.

Objective #4: Chief Campbell, Sgt. Graham, and Officer Strickland attended the monthly LEO meeting on May 31st.

Objective #5: There was one request for installation of a child seat this month.

Goal #4: Conduct special enforcement programs and participate in GHSP campaigns.

Objective #1: We had an officer who participated in a checkpoint that was held by the Carthage Police Department on May 24th in Carthage. It was a large checkpoint with 8 police agencies participating in this checkpoint. Our department also earned 50 points in the GHSP Step Reporting Program for participating in this event.

Our department participated in a checkpoint in Pinebluff on May 31st. A total of 35 citations were written during this checkpoint. Our department earned 75 points in the GSHP Step Reporting Program for participating in this event.

Also, on May 31st our department held a checkpoint in the afternoon. One citation was written. Our department earned 50 points in the GHSP Step Reporting Program for conducting this checkpoint.

Goal #5: Continue current crime prevention programs to maintain the Village's low crime statistics.

Objective #1: We remain fully staffed.

Objective #2: A traffic complaint was received in April about speeding on Shadow Drive. Officers completed 10 speed surveys in the area. No citations or warnings were issued as no violations were seen during any of the speed surveys. Officers will continue to work in this area.

A traffic complaint was received about speeding on Pine Ridge Drive last month. Officers conducted 12 speed surveys, an operation was conducted used the Lidar, and two checkpoints were also conducted. During the speed surveys one citation and one warning ticket were issued for speeding. Officers will continue to work in this area.

Objective #3: Officers have conducted:

House checks – 529 (average 17 a day)

Business checks – 986 Store closings – 58

We continue to have a total of 9 seniors in the Senior Call In Program.

Objective #4: There were no requests for articles this month.

Objective #5: Officers have conducted 68 foot patrols at the Food Lion Shopping Center this month.

Objective #6: No traffic studies were conducted this month.

Objective #7: We have 6 certified child seat technicians. 5 officers and the Sergeant are certified child seat technicians.

Goal #6: Proactive approach in looking for safety concerns.

<u>Objective#1:</u> The Village continues to provide the department with the funds to allow us to buy equipment and provide training to make our officers as safe as possible.

Objective #2: Officers have conducted numerous saturation patrols this month on Lakeview Drive and Pine Ridge Drive.

Sgt. Graham worked with the Village public works crew to reposition ski buoys on Thagard Lake to make boating safer for all.

Objective #3: In our efforts to meet OSHA requirements, quarterly and yearly reviews of the Infectious Disease Control Plan have been scheduled. The next quarterly review is scheduled for June 2018.

Also, the police administrator has updated the material safety data sheets for all hazardous chemicals used by this department from cleaning supplies to fingerprinting supplies to office supplies.

Goal #7: Seek a new camera system for vehicle and body worn cameras.

Objective #1: The new in-car camera system and management system has been installed and is working well.

Goal #8: Continue to participate in the Village's ongoing recycling program.

Objective #1: The police department continues to participate in the Village recycling program.
